
Torch Lake Township Regular Monthly Meeting Bootjack Fire Hall April 21, 2021



The Regular Monthly meeting of the Torch Lake Township Board was called to order at 6 pm by Clerk Isola in the absence of Supervisor Cadwell. The meeting was turned over to Trustee Ambuehl so the Clerk could take the minutes.

Roll call: Ambuehl, yes; Sapino, yes; Moore, yes; and Isola, yes. Cadwell absent

Motion was made by Moore and a second by Sapino to accept the agenda as presented with the addition: Grant Supervisor Cadwell permission to review information on loaders for DPW and make a decision for a possible purchase. All in favor, motion carried.

A motion was made by Moore and a second by Ambuehl to accept the minutes from the February 17, 2021 meeting. All in favor, motion carried.

A motion by Sapino and a second by Moore was made to approve the prepaid bills from the General Fund of \$18283.01, Garbage bills of \$15729.54, and current bills from the General Fund of \$12886.70.

Also a check from the Hubbell Fire Dept. Special Assessment for equipment was made to West Shore Fire for \$6007.17 for a light bar. In addition two checks from Bootjack Fire Dept. Special Assessment. One to North Star Emergency for \$2141.97 for transmission repairs to truck #2 and a check to Darley Co. for \$6463.68 for an LED light bar. Roll call: Isola, yes; Moore, yes; Sapino, yes; Ambuehl, yes. All in favor, motion carried.

Treasurer Moore reported that Superior National Bank has agreed to no service charges on the Hubbell Fire Protection account. A motion by Isola and a second by Ambuehl was made to place the Treasurer's report on file. All in favor, motion carried.

Refuse: Road restriction are still on. We spend \$2800.00 for transmission repairs to the White garbage truck and we will be replacing tires on the Mack sometime in the near future.

A motion by Isola and a second by Moore was made to approve giving Supervisor Cadwell permission to review information on loaders for the DPW and to make a possible decision on a purchase. Roll call: Sapino, yes; Ambuehl, yes; Isola; yes and Moore, yes. All in favor, motion carried.

Public Comment: Wes Koschiek stated that there is a need to secure the cover to the rented dumpster at their shop as unauthorized people are putting garbage in it. We will check with Roger in DPW about a solution.

There being no further business, a motion by Sapino and a second by Moore was made to adjourn the meeting. All in favor, motion carried. The meeting adjourned at 6:20 pm.
